If a draft falls due on a Saturday or Sunday, we draft it the following Monday. We will send out copies of our invoices by mail, e-mail, fax, or DTN the next business day after product is pulled, which should provide ample time should any adjustments need to be made to the draft. It is our policy to count the EFT draft towards your credit line 2 working days after the draft has hit your account. Credit limits will be strictly adhered to.
